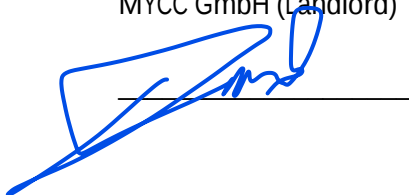

Bathroom Rules

Main Information

Hours

The shower should not be used between 23:00 and 05:30 if possible.

Hygiene

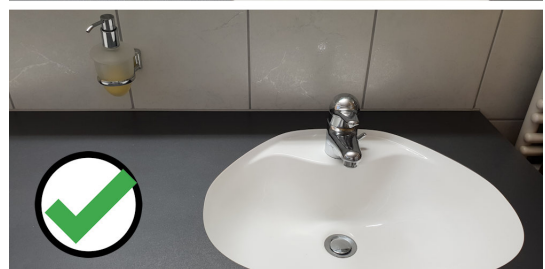
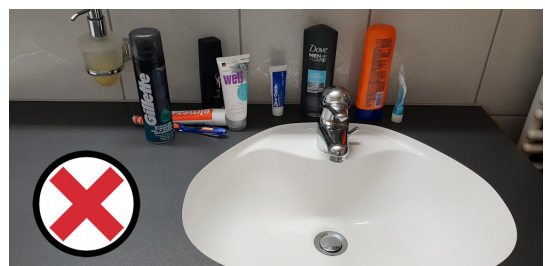
Peeing while standing is prohibited. Please clean the toilet after use, Lavabo and the tub so good, so that the next feels well.

Place to Keep

No tubes, razors, toothbrushes, etc. should be left on the shelves (except shower shampoo). The rest has to be put away.

Ventilate

If there is a window, the window and the door must be opened after using the toilet / bath. Mold only occurs if it is not properly ventilated.



Kitchen Rules

Main Information

Hours

The kitchen may only be used between 06:00 and 22:00. In case of repeated offense, the electricity will be turned off in the kitchen overnight.

Dishes

Every resident is responsible for their own dishes. The Landlord does not organize dishes and pans. The dishes must be put away in the kitchen cupboards as soon as they are dry. Dirty dishes are disposed of without any refund by the landlord.

Fridge

Each resident has his personal compartment, which is marked with his room number. Only eat their own food. Expired food will be disposed of without any refund by the landlord

Oven

The oven tray must be cleaned after each use. The landlord does not replace dirty sheets, but disposes of them without replacement.

Dishwasher

After each wash, empty the dishwasher completely.



Kitchen Rules

Miscellaneous

Rent

The rent must always be paid in advance. Example: The rent for October must be credited to the landlord's account no later than October 1st. If you have financial problems, contact us early. Reminders are charged with at least CHF 50.00.

Periods of Rest

There must be silence between 22:00 and 06:00. The roommates may not be disturbed.

Smoking

Smoking in the rooms and in the apartment is prohibited. It must not be smoked out of the window. In the event of a violation, at least CHF 850.00 will be charged.

Drugs

Consuming hard and soft drugs (including Cannabis) is strictly prohibited. Drink so much alcohol that you do not bother anyone. In the event of a breach, notice of termination is given immediately. Drugs = ZERO Tolerance!

Guests

Basically, the room is calculated only for one person. A friend is allowed to stay a maximum of 1 night per week and only if no one feels disturbed. Other guests are not allowed. The landlord can prohibit the visit of all guests without giving any reason.

Furniture in the Apartment

For safety reasons (fire police) no furniture may be placed in the common rooms or items such as shoes, garbage bags, clothes, etc. set up / stored. The landlord disposes of all items without consultation and without compensation. The placement of furniture in the public spaces is prohibited.

Television
